# **ICE Out of Monroe County**

- ➤ On January 25, 2017, President Trump's Executive Order 13768 broadened "interior enforcement" priorities to target **ALL** undocumented immigrants for deportation *regardless of their individual circumstances*.
- ➤ In the three years since, this massive expansion has devasted immigrant families and communities around the US—including right here in Indiana's Monroe County.
- MoCo Sheriff Brad Swain voluntarily collaborates with ICE (Immigration Customs and Enforcement) to detain our neighbors and friends. These detentions are unnecessary, unconstitutional, and immoral. We need to stop them NOW.

## **Sample Letter**

Dear:
I have recently learned that the Monroe County Sheriff is helping ICE detain and deport our community members. I disagree with his policy.
Immigration enforcement should be left to the immigration authorities and should not be conducted by our local law enforcement. This type of cooperation hurts our community by forcing our neighbors to live in fear. Our neighbors, no matter where they are from, should feel safe in our community.
The Sheriff's cooperation with ICE can also harm the trust that immigrants feel in our law enforcement. Studies have shown that when law enforcement authorities work with ICE, immigrants feel afraid to cooperate in investigations or report crimes against them. This reluctance will harm our entire community.
I do not want family separation to happen in our community. I ask that you work with other Monroe County elected officials to prevent the Sheriff from continuing this policy. Please stop funding the jail's cooperation with ICE.
